All Set-ups must be completed by 9:30 am Saturday and Sunday and **VEHICLES MUST BE REMOVED FROM THE AREA** by these times. No set-up is permitted after these times. No teardown is permitted until after the Village is closed for the day. All boxes and containers must be kept out of sight. Tables must be covered to the ground in the front and on the sides. Authentic Early American dress is a requirement. All food service and fire safety regulations must be followed. Exhibitor must provide their own tables, chairs, display racks, etc. Each exhibitor's area must be kept clean during and after the show. Trash is to be put in dumpsters provided. The Tiffin-Seneca Heritage Festival will not be responsible for any theft, loss, liability, property damage or accident. Security is provided after dark on Friday and Saturday nights. **ALCOHOLIC BEVERAGES PROHIBITED IN CITY PARK.** Please remember that this is an outside show.
