**When:** September 16 and 17, 2017  
**Time:** Saturday 10:00am to 6:00 pm; Sunday 10:00am to 5:00pm  
**Where:** Hedges-Boyer Park (Lower Level) – Across the Street from the Tiffin YMCA in Tiffin, Ohio  
**Fees:** \$50.00 for 2 days per space for Craftsmen, and Exhibitors with items for sales  
**Requirements:** No restrictions on Dress and Booth since you will be located outside the 19th century era.

Make check payable to Tiffin-Seneca Heritage Festival and mail it, with your completed and signed contract, to the address above. NO REFUNDS, unless space is not available or contract is rejected. Your cancelled check is your receipt. All signed contracts must include full payment of fees to be accepted. Contracts should be returned by 9/15/17 to guarantee a space. After this date, all remaining spots will be filled at random. Ice will be available on site for sale. All Set-ups must be completed by 9:30 am Saturday and Sunday No set-up is permitted after these times. No teardown is permitted until after the Village is closed for the day. All boxes and containers must be kept out of sight. Tables must be covered to the ground in the front and on the sides. Exhibitor must provide their own tables, chairs, display racks, etc. Each exhibitor's area must be kept clean during and after the show. Trash is to be put in dumpsters provided. The Tiffin-Seneca Heritage Festival will not be responsible for any theft, loss, liability, property damage or accident. A security patrol (non-professional) is provided after dark on Friday and Saturday nights. Must provide vendor's license number. **ALCOHOLIC BEVERAGES PROHIBITED IN CITY PARK.** Please remember that this is an outside show.

### The concessionaire agrees:

1. As partial consideration for being allowed to participate in the Tiffin-Seneca Heritage Festival in Tiffin, Ohio that they are an independent contractor and not an agent for the committee.
